Summary	The J. M. Smucker Co. has issued a recall for peanut butter because it might be contaminated with Salmonella.

Product	Peanut Butter
Reason	Salmonella
Illness	Salmonella is an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with Salmonella often experience fever, diarrhea (which may be bloody), nausea, vomiting and abdominal pain. In rare circumstances, infection with Salmonella can result in the organism getting into the bloodstream and producing more severe illnesses such as arterial infections (i.e., infected aneurysms), endocarditis and arthritis.
Instructions	Please isolate any affected product (see below table) and destroy it in a secure manner to prevent unauthorized consumption. If you have product stored out of the case and are unsure of the code date please destroy this product also. For credit, contact your sales representative if you receive truck deliveries or contact your local Gordon Food Service Store if you purchase in the store. Please note that proper procedures must be followed and these cases may not be returned to your distributor. If you have further distributed any of these products, then you are responsible to notify all consignees of this recall.
