This is an important communication from your food supplier, Gordon Food Service. We are contacting you about a Recall event. Gordon Food Service has deployed the Instant Recall™ solution, an automated Recall event notification system.

Hormel is conducting a Recall of Fire Braised Chicken. The reason for the RECALL is due to potential contamination with Foreign Material. There is a potential food safety concern.
